## **Conway Named Placer County Economic Development Director**



Sherri Conway was appointed Placer County's new Economic Development Director to replace retiring Director Dave Snyder After a nationwide search and a rigorous evaluation process, the Placer County Executive Office announced that Sherri Conway has been appointed Economic Development Director effective December 5. Conway replaces Dave Snyder who retired to the new position. She previously served as planning director for the City of Colfax as well as planning director for the Village of Lake Placid, New York before joining the Placer County team in 2014.

Since joining the County in the Community Development Resource Agency, she has been the planning lead for development of the Sunset Area Plan, an 8,100-acre area in unincorporated Western Placer County where planned university, technology and residential developments are expected to drive economic growth for decades. The land is owned by the County and has been considered a potential

## **Investment Tips for Millennials**

If you are a "millennial" - a member of the age cohort born anywhere from the early 1980s to the late 1990s - then you're still in the early chapters of your career, so it may be a stretch for you to envision the end of it. But since you do have so many years until you retire, you've got the luxury of putting *time* on your side as you save and plan for retirement.

Here are some suggestions for making the best use of that time:

Invest early - and often. Even if you are at the very beginning of your career, make investing a priority. At first, you might only be able to contribute a small amount each month, but something is far better than nothing – and after a year or so, you might be surprised at how much you've actually put away.

Take advantage of your employer's retirement plan. If your employer offers a 401(k) or similar plan, contribute as much as you can afford. At the least, put in enough to earn your employer's match, if one is offered. Your contributions can lower your taxable income, and your earnings can grow on a tax-deferred basis.

Invest more as your earnings increase. As your career advances, and your earnings rise, you'll want to increase your contributions to your 401(k) or similar plan. And if you ever "max out" on your annual 401(k) contributions (the limits change over time), you can probably still contribute to another tax-advantaged retirement plan, such as a traditional or Roth IRA.

Thus far, we've only discussed, in general terms, how much and how often you should invest. But it's obviously just as important to think about the *type* of investments you own. And at this stage of your life, you need an investment mix that provides you with ample opportunities

for growth. Historically, stocks and stock-based vehicles provide greater growth potential than other investments, such as government securities, corporate bonds and certificates of deposit (CDs). Of course, stocks will rise and fall in price, sometimes dramatically. But with decades ahead of you, you do have time to overcome short-term losses. And you may be able to reduce the effects of market volatility by spreading your dollars among many different stock-based investments, along with a reasonable percentage of bonds and other, more conservative securities. Here's something else to consider: Many millennials want more from their investments than just good performance - they also want their money to make a difference in the world. This interest in "impact" investing (also known as "socially responsible" investing) has led some of your peers to screen out companies or industries they believe have a negative impact on society in favor of other businesses that are viewed as contributing to a more sustainable world. If this viewpoint resonates with you, then you may want to explore these types of investment opportunities with a financial professional.

## **County Secures South Placer Buildings and Programs**

Late last year the Board of Supervisors voted unanimously to approve the purchase of two key buildings in South Placer County: an office building on Sunset Boulevard in Rocklin and a 20-unit apartment complex in downtown Roseville. Although these are two very different properties, under county ownership they represent a commitment to providing county residents with much-needed services.

Placer County began leasing space in the office building on Sunset Boulevard in 2009 and now occupies 95% of the facility. The 97,477 square-foot building houses staff and programs from various county departments including Child Support Services, Veteran's Services Office, and multiple Health and Human Services Department programs such as Work Experience Production Center and Employment Services Center, Children's System of Care, Public Health Nursing, and Women Infants and Children. Additionally, beginning this month the Placer County Auditor-Controller will begin occupying the remaining space in the building.

By purchasing the building the County is able to guarantee continuity of vital

programs that are critical to the lives of so many county residents, including some of our most vulnerable populations, including our children. Additionally, purchasing the property protects the County's nearly \$3 million investment in the building and ensures the county will not be faced with rising rental costs for the facility in years to come.

In another step toward providing continued and expanded services to residents of Placer County, the Board of Supervisors approved the purchase of the multi-family residential building in Roseville. The building purchase will help to implement the Placer County Mental Health Services Act by providing housing for individuals with serious mental illness. The property is ideal for housing mentally ill adults as its 20 studio units each include a full bathroom and kitchenette, which will allow for independent living rather than the shared-housing option that is more commonly available in housing programs for mentally ill individuals.

Another benefit of the building is its location. In addition to being near shopping, food services and transportation, it is also within close proximity to complimentary services. The Gathering Inn, which provides services to homeless individuals, is located on the same block and the Placer County Adult System of Care's Cirby Hills mental health facility is fewer than three miles away.

The funds for the purchase of this building come from a pool of money that was set aside over the past three years for just this purpose – to purchase or develop additional housing resources for individuals with mental illness. While the operation of the facility will ultimately be turned over to a nonprofit organization with extensive experience in this field in Placer County, the purchase of the building by the county will provide a secure location for these much needed programs.

As a member of the Board of Supervisors I take very seriously my responsibility with public funds, and very often the decisions I make are very difficult. In the case of purchasing these two buildings I feel confident that Placer County's residents will benefit from the expansion and consistency of the vital services being offered in these locations. I look forward to continuing to support changes that improve the lives of all Placer County residents.

"With our Sunset Area Plan and plans for sustainable economic redevelopment in North Lake Tahoe, we are on the cusp of some incredible and transformative things for Placer County. I am truly honored and excited to be a part of them," Conway said. "The overall objective [of the plan update] is to re-envision and rebrand the Sunset Industrial Area to fully implement the County's long-term vision for the plan area as the economic engine for the County. Overall, the future development of the Sunset Area has the potential to create more than 50,000 jobs."

With focus on a jobs center and the benefits that the surrounding residents will enjoy, Conway wants small business owners to know that they are equally important to the county's economy and that she and her department recognize the barriers they may encounter. One of Conway's initiatives is to make sure that small businesses understand and have access to the resources they need to grow.

"Recognizing that small businesses are the backbone of Placer County's economy, one of my initiatives will be to foster a vibrant entrepreneurial climate that supports on-going small business growth and job creation by partnering with our family-owned and 'Main Street' businesses to better understand their needs," noted Conway. "From entitlements to permits, the process of establishing a new business can be overwhelming for some. I want to make sure that our office can be an advocate to get them through their issues, to get them up and running. I see a real opportunity there to engage in a dialogue."

As director of the Office of Economic Development, Conway's main role will be to provide vision and leadership in planning, growing and managing economic development programs and projects. She will also manage staff responsible for economic and business development, film production coordination, and workforce and job development efforts.

"It is gratifying that the top candidate comes from within and can immediately build upon her intimate knowledge of our organization and community. I am excited about what Sherri will bring in terms of her experience, enthusiasm and energy," commented County Executive Officer David Boesch. "Sherri is well-versed in our plans and goals in the land development arena in Placer. With her extensive experience in economic development, she's the perfect person to work with our business community and partners to capitalize on the incredible opportunities that are before us and ensure we achieve those goals going forward."

Conway holds a Bachelor of Science degree in environmental science from the State University of New York, College at Plattsburgh, and a Master of Science degree in resource management and public administration from Antioch University in Ohio. She and her husband reside in Ophir, the former county seat.

#### BUSINESS ADVANTAGE NETWORK

A program that Conway would like to highlight is the Business Advantage Network, a team of workforce development professionals that provide no-cost hiring assistance to employers. Marcy Schmidt splits her time between Auburn and Rocklin to supervise the program.

"The beauty of this program is the untapped potential. On the Human Services side, we provide vocational training for young people and those on public assistance. But on the Economic Development side, our primary customer is the small business owner to match them with qualified candidates with the appropriate skillset," stated Schmidt. "We have over 2,500 people who receive our daily job leads, organize monthly recruiting events, and tailor our program to meet the needs of business. From entry-level to skilled professionals, we can and want to be a resource for small business owners."

## EDUCATION UPDATE

## Rocklin Unified School District's Transitional Kindergarten and Kindergarten is like the start of a well thought out Business Plan!

"*Synergy.*" It is a buzz word so common in the business world, and it has a place in the education arena too. I've witnessed firsthand how *synergy* plays a critical role at RUSD as our students move from grade to grade in our elementary to middle to high schools.

A perfect example of this path to future success came during Whitney High School's Mock Interview program recently. I, along with several others (many Chamber leaders too – thank you!) put the students through a real-life job interview scenario. I was excited and ready to make sure I handed out advice and tips to get the students prepared for any kind of interview thrown their way. And then the personified version of RUSD *synergy* came along. A young lady, not just smart, but also polished and prepared, added an element that speaks to the experience all our kids have.

She answered my exercise questions superbly and when I asked her what her future goals were, she said, and I am paraphrasing here, that while she recognizes the business world can be tough, she just wanted to make sure

whatever she was doing, she was doing it with a *happy heart*. I was pleasantly surprised. And I'm a pretty positive person!

Rewind about a decade or more and you'll see how those happy hearts started in our Transitional and Kindergarten programs. The education buzzphrase these days is 21st century learning skills to help our students succeed in the ever changing landscape of technology and progress. The leadership from our Board of Trustee and Superintendent Roger Stock ensures RUSD provides that and much more. Amazingly our kindergarteners are learning how to code and even be scientists in a lab and of course they are also being prepared with academic and social skills to succeed. They become richly, well rounded adults.

"The children are so excited and they take their 'job' very seriously. They are funny, loving, clever and eager with a desire to learn. TK is truly a gift of time to the children enrolled, time to grow and develop at an appropriate pace. They get hands on opportunities to explore and question the world around them. They are exposed to

science, math, language arts and more in activities that challenge their thinking and often get them messy! You could find us any day with our hands in mud, goo, finger paint, rice, play dough, cornmeal or birdseed! We may be weighing, measuring, sifting, pouring, cutting or gluing. Or we might be singing and dancing

with scarves, ribbons or a parachute. TK students might look like they are just playing, but there are strong learning foundation being created. Play is a way for the students to practice what they learn and is not a luxury but a necessity," according to dedicated TK teacher Allison Moores at Cobblestone Elementary.

"Transitional Kindergarten/Kindergarten is the beginning of a child's educational career and our TK and K team take that seriously. Our goal is to create life long learners by tapping into each child's sense of wonder and joy of discovery," says Ann Borchers, beloved Kindergarten teacher at Rock Creek Elementary. "We want them to love their new career of being a student and learn the confidence builder of being responsible for their own choices."

"We also have a wide development span with some not knowing their letters and sounds or not even how to write their name when they started to some reading at a second grade level. So we are mindful and purposeful in diversifying our curriculum to make sure we bring each child along to reach their potential while remembering to have fun all the while. We as a team work together to come up with strategies of how to best meet children's needs both academically and emotionally," continued Borchers. "It is so rewarding to see them come to us as babies and leave as confident students. I love what I get to do each day." "Mrs. Holly Snyder and Mrs. Patty Knorzer have been the foundation for the TK program in RUSD and through enormous hours of hard work created a model that has led to tremendous success of their students and a



model for the other TK schools within our district," according to Mark Williams, Principal at Rock Creek Elementary. "Kindergarten teachers Mrs. Borchers, Ms. Hellen, and Mrs. Campus continue to provide tremendous opportunities for their students on a daily basis. I can't begin to tell you how many

parents have approached me and let me know how these teachers have impacted their son/ daughter (and I've only been here for four months)! On a weekly basis, I am witnessing firsthand the emphasis on communication they place with parents and the care they take for their students."

As always, thanks for letting me share. Our RUSD community is grateful to be part of this great, strong, safe community and we appreciate your support. Here's hoping *you* have a *happy heart* and continued personal and professional success in 2017!

## City Streamlines Small Special Event Process

The **City of Rocklin** is continually searching for ways to improve its processes and services to meet the needs of the growing community. As more entrepreneurs join the Rocklin collective, the opportunity for partnership increases, as do the chances to identify and address concerns.

In the latter half of 2016, the need to update the special event permitting process came to light.

A business new to the City was interested in holding a relatively small special event to celebrate their grand opening. The deadline was short and the City's special event permitting process needed more flexibility to discern between small and large events, and expedite the process to mitigate impacts to surrounding neighborhoods and businesses.

In response to the need, City staff developed a "Small Special Event Pilot Program" intended to reduce the approval process to only two days for small events meeting certain criteria. These small events, which could include groundbreakings, ribbon-cuttings, or grand openings, would have 75 attendees or fewer, occur between 8 a.m. and 10 p.m. on a single day, with no special lighting required.

Alcohol sales or consumption can be allowed with the approval of a one-day license from the California Department of Alcoholic Beverage Control and the Rocklin Police Department. If event elements require approval of the Rocklin Police or Fire Departments, they must be contacted a minimum of 10 days in advance.

A complete list of criteria to qualify for the "Small Special Event Pilot Program" can be found on the City of Rocklin's website at www.rocklin.ca.us/smallevents.

City staff is confident the new process will streamline small event approvals, allowing businesses and others the ability to celebrate or commemorate occasions with ease while protecting surrounding neighborhoods and properties. The City is pleased to say that while the business mentioned earlier in the article did not host their initial grand opening, a ribbon cutting was held on a later date and the businesses is now in successful operation.

## Sales and Use Tax Rate Decreases

The statewide sales and use tax rate will decrease one quarter of one percent (0.25%) from 7.50 percent to 7.25 percent on January 1, 2017. The decrease in the statewide rate is effective for all cities and counties in California; however, the actual sales and use tax rate may still be higher than the statewide rate in many jurisdictions in California due to the addition of district taxes.

## Why is the sales and use tax rate decreasing?

Proposition 30, *The Schools and Local Public Safety Protection Act of 2012*, was approved by California voters in November 2012 to temporarily increase the sales and use tax by 0.25 percent. The sales and use tax imposed by Proposition 30 expired December 31, 2016.

#### Where can I find more information?

(Pacific time), except holidays.

## **Tommy A Helps Kids in Need**

On Saturday, December 3, Tommy Apostolos Fund hosted its annual Holiday Shopping Spree, an opportunity for 361 low-income children to "shop" at Kohl's in Roseville for much-needed warm clothing.

For almost 30 years, The Fund has worked directly with Roseville school district teachers and staff who identify worthy students from within the local community. This year, the students were paired with 710 volunteers to escort them through the store to shop outside of Kohl's normal business hours. Noteworthy volunteers included Placer County police and fire personnel, councilmembers, judges, and CEOs. After Kohl's generous discounts, the children each had \$125 to spend on new, warm clothes, shoes and other essentials.

On hand was Tommy Apostolos' granddaughter, Lillie Apostolos, who eagerly greeted students and families individually and personally escorted them into the store. Roseville School District Superintendent Derk Garcia introduced students to their respective school principal, who then paired the students with two volunteers each. The students were guided through clothing, coats and sweaters, and shoes where they were able to try on and purchase items of their choosing.

The Tommy Apostolos Fund, or "Tommy A", as it is casually known, was established in 1988 in memory of Tommy Apostolos, a lifetime Roseville resident whose passion was helping children in need. The organization raises funds throughout the year to purchase new clothing for children in need. Today, The Fund provides nearly 500 children each year with clothing; shoes, and school supplies.

"Many people are unaware that a significant need in our community exists," said Hallie Romero, executive director at Tommy Apostolos Fund. "Tommy A is honored to fill the gap for many families in need. We rely on the generous support of our volunteers to help kids in our local community get the warm clothes they need during the holiday season."

## WJU Designer Frank Gehry Awarded Presidential Medal of Freedom

Frank Gehry, who designed the original buildings at **William Jessup University**, was among 21 people that President Barack Obama awarded the 2016 Medal of Freedom.

A world-renowned architect, Gehry's best-known

world's most influential living architects," said John Jackson, President of William Jessup University. "We have a tremendous legacy that the university will always cherish. The original buildings won design awards and the campus additions that we've made outdoor campus with classrooms, dormitories, offices, lounges and athletics.

William Jessup opened its doors in August 2004 as the first and only WASC accredited private four-year Christian university to have its main campus located

buildings include the Walt Disney Concert Hall in

Los Angeles, the Dancing House in Prague and the Guggenheim Museum in Bilbao, Spain. He was also responsible for the redesign of the Art Gallery of Ontario in Toronto.

William Jessup's 125-

acre grounds were originally designed by Gehry and housed the western headquarters and warehouse location for furniture manufacturer Herman Miller. Miller contracted the world-renowned architect to build a 400,000-square-foot factory. In 1991, Gehry's design was awarded the National Honor Award by the American Institute of Architects (AIA).

"It's always been a tremendous source of pride that our campus is connected to Frank Gehry, one of the over the years have also been award-winning efforts."



"He spent his life rethinking shapes and

mediums, seemingly the force of gravity itself," President Obama said. "Frank Gehry's work shows that while buildings may be fixed to the ground, like all great art they can lift our spirits, they can soar."

Looking to relocate, San Jose Christian College purchased the Herman Miller property in 2002 and changed the name to William Jessup University, after its founder. After much renovation, the original warehouses were retro-fitted into a spacious indoorin the greater Sacramento area, just 25 miles northeast of Sacramento.

The campus renovation received the Best Rebuild/ Renovation Award from the Sacramento Business Journal in March 2005 and was similarly recognized in 2006 by the San Joaquin chapter of the AIA. As the University has grown, Gehry's design has become a permanent staple of campus architecture. In 2010, an entirely new apartment building was unveiled on campus that also received an AIA award.

Earlier this year, the university completed its latest project, a nearly \$13 million campus expansion featuring a new dormitory that houses 210 students.

"William Jessup continues to make impressive strides since relocating to Rocklin nearly 12 years ago," said Mike West, Chairman of the William Jessup University Board of Trustees. "We are thrilled to be opening our doors and creating a new home for more students."
