## **ROCKLIN UNIFIED SCHOOL DISTRICT BOARD OF TRUSTEES SELECT RACHELLE PRICE AS PROVISIONAL APPOINTMENT**

**Rocklin, CA** – During a special Board Meeting on Wednesday, September 18, Rocklin resident and Rocklin Unified parent Rachelle Price was unanimously selected from seven total candidates to fill a provisional appointment on the RUSD Board of Trustees, effective immediately.

Mrs. Price is a small business owner and mother of five children. The Price family has lived in Rocklin for 19 years and continues to help make the city a vibrant place to live, work and play.

Trustee Price has participated in a number of RUSD school activities, including but not limited to the Granite Oaks Middle School Strategic Planning Committee (2015); the Rocklin High School Strategic Planning Committee (2016); the Granite Oaks Middle School Site Council, where she served as President (2015-2019); the RUSD Comprehensive Sexual Health Education Committee (2017); and the Rocklin High School Parent Club, where she currently serves as President (2017- present).

Although she spends much of her time helping RUSD schools, Mrs. Price truly goes above and beyond in the Rocklin community as well. For the last several years, Price has volunteered her time to coach the Rocklin Pony Champions special-needs baseball team; to lead the Rocklin Day of Service; to lead the Rocklin Historic Quarry District Christmas tree donation program; and to advise a youth leadership conference.

“Rocklin is an amazing city and we are nationally recognized for our high-quality of life, including top-rated schools,” said Price. “I value the unparalleled reputation of excellence we enjoy and want to continue this tradition of excellence by contributing to the positive things happening [in our community].”

Trustee Price was provisionally appointed to the Rocklin Unified School District Board of Trustees because of a vacant seat on the Board after the resignation of former RUSD Trustee Susan Halldin. Board President Eric Stevens shared the following regarding the change:

*“We would like to express our sincere gratitude to Mrs. Halldin for her dedicated service and tremendous contributions to Rocklin Unified during her tenure. We look forward to working with Trustee Price to continue to bring positive change to our schools and to uphold the RUSD standard of excellence—both in education and in our community.”*

Trustee Price will serve on the RUSD Board of Trustees until the next regular election in November 2020. The candidate selected in the November 2020 election will serve the remaining two years of the current term, ending in November 2022.
