COVID-19 March 26, 2020 Update: Closure of Rocklin Unified School Extended through May 1, 2020

March 26, 2020

Dear RUSD Students, Families and Staff,

I hope you are all doing well in these unprecedented times in our nation, state, and local community. Today I am sharing important information that Rocklin Unified will extend our school closures through Friday, May 1, 2020 with return to school on Monday, May 4, 2020 to continue to limit the community spread of COVID-19. We, and all school districts in Placer County, are following guidance from our Placer County Office of Public Health and coordinating with the Placer County Office of Education.

We understand how challenging these decisions are for our students and families and we appreciate your support, flexibility, and patience. We are very grateful for all that our students, staff and families are doing to support safety, continuity of education and caring for our children.

The following information is intended to provide you with more details and support during our extended school closure.

School Closure Timeline

Rocklin Unified School District will close all schools at least through May 1, 2020 in response to the COVID-19 emergency. We will continue to provide updates as this situation evolves. We are hopeful to see you all again on Monday, May 4, 2020, but also realize there is a real possibility we may have to keep our schools closed and continue Distance Learning until the end of the school year. We will continue to monitor the situation closely in collaboration with public health officials and provide updates as soon as we receive pertinent information.

Milestone events

As school closures possibly continues to the end of the school year, it also impacts important life moments like graduations, promotions and other important celebrations and events. We are diligently working to protect these events, to any extent possible,

and considering all options if the current shutdown lasts beyond the end of the traditional school year.

Continuity of Learning

RUSD's teachers and principals have been working tirelessly to adapt to this new world of remote learning as we seek to provide a continuity of learning to our students during this extended school closure. I am very proud of how quickly this has occurred and it is a true testament to the professionalism and dedication of our teacher, principals, and others. Students, teachers, and families are all in a "learning by doing" phase of remote learning. All of us in RUSD are committed to use this initial learning phase to improve and enhance our remote learning in the coming weeks. We will update you about expectations for student work as we work with our labor partners and make changes to improve our remote learning over this extended time.
